ORDER GRANTING APPLICATIONS TO INTERVENE

On April 27, 2016¹, the Office of the Public Counsel ("OPC") filed a complaint with the Missouri Public Service Commission against Laclede Gas Company ("Laclede") and Missouri Gas Energy ("MGE"). The complaint alleges that Laclede and MGE's rates are excessive and should be reduced.

The Commission issued notice of the complaint and allowed time for interested parties to apply for intervention. The Commission received timely intervention requests from Midwest Energy Consumers' Group and The Missouri Division of Energy. Objections to those requests were due May 31. No party objected to those applications to intervene.²

Commission Rule 4 CSR 240-2.075(4) allows the Commission to grant intervention to a person who has an interest different from that of the general public and which may be adversely affected by a final order arising from the case, or if granting intervention would
