**ORDER SETTING TIME FOR FILING  
AND EXTENDING DEADLINE FOR RECOMMENDED REPORT AND ORDER**

Issue Date: March 8, 2017

Effective Date: March 8, 2017

At the procedural conference held on this date, the Senior Regulatory Law Judge announced that the parties would have 10 days in which to file their proposed settlement agreement and/or recommendations for a procedural schedule. Because the 10<sup>th</sup> day falls on a Saturday, the date for filing is extended until March 20, 2017.

In addition, because setting a mutually agreeable procedural schedule caused delays, there is not sufficient time remaining in which to hold a hearing or issue a recommended report and order within the 100-day deadline set out in Commission Rule 4 CSR 240-2.070(15)(G). Therefore, under the authority granted in that provision, the regulatory law judge finds that good cause exists to extend the date for the recommended report and order as set out below.

**THE COMMISSION ORDERS THAT:**

1. The parties shall jointly file a settlement agreement disposing of this matter, or separately or jointly file proposed procedural schedules no later than March 20, 2017.
2. The time for issuing a recommended report and order is extended for good cause until June 30, 2017.
3. This order shall be effective when issued.
