THIRD ORDER DIRECTING STATUS REPORT

Issue Date: June 29, 2017

Effective Date: June 29, 2017

On April 11, 2017, the parties met at a procedural conference in order to discuss settlement and/or a proposed procedural schedule to resolve the issues in this case. At the end of the conference, the parties notified the Regulatory Law Judge that they were continuing negotiations and were hopeful that a resolution could be reached. Since that time, the parties informed the Regulatory Law Judge on two occasions that they needed additional time to negotiate.

The Commission directed that the parties file either a status report indicating when they believe their negotiations would conclude or when they would be able to file a proposed procedural schedule or other pleading requesting Commission action. On May 25, 2017, the parties filed a status report indicating that it would be at least June 15, 2017, before they would conclude their negotiations. On June 26, 2017, the parties filed another status report indicating it would be at least July 20, 2017, before

they would conclude their discussions. Therefore, the Commission will direct the parties to file an additional status report.

THE COMMISSION ORDERS THAT:

1. The complainants and respondents in this matter shall file joint or separate status reports indicating when they believe they will conclude their negotiations or when they will file a proposed procedural schedule or other request for Commission action, no later than July 20, 2017.

2. This order shall be effective when issued.
