**ORDER DIRECTING FILING AND GRANTING
EXTENSION OF TIME TO FILE STAFF REPORT**

Effective Date: February 6, 2018

On December 6, 2017, Lisa Lambert filed a complaint with the Missouri Public Service Commission (“Commission”) against Spire Missouri, Inc. d/b/a Spire (“Spire”). On February 5, 2018, the Commission’s Staff filed a Motion to Compel Discovery and Motion for Extension of Time. Staff alleges that Spire has failed to provide any or inadequate answers to a number of data requests submitted by Staff to Spire. Staff seeks an order compelling Spire to respond to the data requests. Staff states that as a consequence of Spire’s failure to respond to discovery, Staff has been unable to properly investigate the facts of Ms. Lambert’s complaint and prepare a report to the Commission, which was ordered to be submitted by February 5, 2018. Therefore, Staff requests an extension of time until May 17, 2018 to complete its discovery and submit a report to the Commission.

The Commission finds Staff's Motion for Extension of Time reasonable and will grant that motion. The Commission will also direct Spire to respond to Staff's Motion to Compel Discovery.

THE COMMISSION ORDERS THAT:

1. Staff's Motion for Extension of Time is granted. The deadline for Staff to investigate this complaint and file a report with the Commission is extended to no later than May 17, 2018.
2. Spire Missouri, Inc. d/b/a Spire shall file a response to Staff's Motion to Compel Discovery no later than February 16, 2018.
3. This order shall become effective when issued.
