## ORDER SETTING PROCEDURAL CONFERENCE

On December 6, 2017, Lisa Lambert filed a complaint with the Missouri Public Service Commission ("Commission") against Spire Missouri, Inc. d/b/a Spire. On May 17, 2018, the Commission's Staff filed a *Staff Report*.
