

Jim,

This is in response to Sprints physical collocation request for the SWB Kansas City, Missouri McGee (KSCYMO55) Central Office. As you are aware, the arrangement requested by Sprint for this collocation application necessitated a cost model based upon Individual Case Base (ICB) pricing. This memo will provide a complete cost quote to Sprint for ICB-based costs for this collocation application.

Attached are the completed collocation application (Attachment 1), a Construction Cost Summary For Physical Collocation (Attachment 2) and a proposed floor plan for the collocation cage (Attachment 3). Per the Sprint/SWBT Missouri Interconnection Agreement, the Construction Cost Summary provides a breakdown of the costs, including Subcontractor Charges. The quote as indicated on the Construction Cost Summary is valid for 65 days from the date of this letter. Thereafter, a new quote would be necessary.

This price quote is based upon Sprints latest revised application dated December 22, 1998 and will provision a 120 square foot cage (8'x15'), (1) POT frame enclosed in a lockable cabinet located adjacent to the collocation cage, (1) 20-AMP and (1) 50-AMP standard power arrangements, (1) 120 volt/20 amp AC circuit, (1) DS3 and (400) VG (ADSL capable) termination's. Per the collocation application revisions, SWBT will provide any/all chassis/modules/panels necessary to terminate connections on the POT frame as specified in the SWBT Interconnector's Technical Publication for Physical Collocation. Because the POT frame will be located adjacent to the collocation cage, no cable costs from the POT frame to the collocation cage are included in this quote.

SWBT will begin preparing the requested collocation arrangement upon receipt of a copy of this letter with an original signature of an authorized representative in the space provided below, a check for 50% of the total estimated preparation charges indicated in Attachment 2, and a complete detailed floor plan that provides the equipment layout in the dimensions provided by the SWB drawing.

By returning the signed original and the check, your company would be committed to reimbursing SWBT for the costs incurred in preparing the requested arrangement even if your company ultimately decides not to physically collocate. The remainder of the preparation charges shall be payable upon notification by SWBT that the job is complete.

SWBT makes floor space available for collocation on a "first come first served" basis. Sprint acknowledges that it is SWBT's policy not to reserve floor space for collocation until SWBT is in receipt of the first 50% of the physical collocation preparation charge by another CLEC, or otherwise, prior to such payment by Sprint as would secure the space. In any event, by accepting this price quote, Sprint agrees to hold SWBT harmless.

Sprint agrees to maintain at Sprint's expense, insurance as specified in the SWBT Technical Publication, Section 1.5. All insurance must be in effect on or before the date on which SWBT begins construction and shall remain in force through job completion, job acceptance, and occupancy.

SWBT expects that the interval for this project will be 90 days from SWBT's receipt of the check for 50% of the preparation charges and this signed document. However, if you elect to proceed with this arrangement, and SWBT receives your confirmation at the same time SWBT receives multiple confirmations for other arrangements within the same geographical area, SWBT proposes that a mutually agreeable negotiated interval be established.

Sprint acknowledges that this quote is based upon completion of the NEBS Compliance Review and a satisfactory Equipment Review for the ADSL equipment identified by Sprint to be placed in the central office. In addition, Sprint agrees to pay for any adjustments to the cost quote necessary as a result of specific cabling requirements and/or other charges that may arise as a result of technical requirements identified in the Equipment Review process.
