ORDER APPROVING COMPLIANCE TARIFF SHEETS

Issue Date: February 19, 2009

Effective Date: March 1, 2009

On January 27, 2009, the Missouri Public Service Commission issued its Report and Order rejecting the tariff filed by Union Electric Company, d/b/a AmerenUE and directing AmerenUE to file a revised tariff to effectuate the terms of the Report and Order. AmerenUE filed a revised tariff on January 30, in compliance with that order. AmerenUE's tariff carries an effective date of March 1.

On February 10, the Commission's Staff filed its recommendation regarding AmerenUE's compliance tariff. Staff concludes the tariff complies with the Commission's Report and Order, and recommends the Commission approve the compliance tariff to be effective on the date requested by AmerenUE. Staff notes the Report and Order indicated AmerenUE's annual revenue requirement would increase by approximately \$162.6 million. As part of its review, Staff calculated the annual revenue requirement change in more detail and requests that the Commission's order approving the compliance tariff specifically state that the revenue requirement increase resulting from the Report and Order is \$161,709,205 annually.

On February 11, the Commission ordered that any party wishing to respond to Staff's recommendation do so no later than February 18. No party filed a response.

The Commission has reviewed the proposed tariff and Staff's recommendation. Based on that recommendation, the Commission concludes the submitted tariff complies with the Commission's Report and Order and shall be approved.

THE COMMISSION ORDERS THAT:

1. The proposed electric service tariff sheets submitted under Tariff File No. YE-2009-0561 by Union Electric Company, d/b/a AmerenUE, are approved, effective on and after March 1, 2009. The specific tariff sheets approved are:
