## **ORDER GRANTING MOTION FOR EXTENSION OF TIME**

Issue Date: March 6, 2009 Effective Date: March 6, 2009

On March 2, 2009, Kansas City Power and Light Company ("KCPL") and KCP&L Greater Missouri Operations Company ("GMO") filed a status report addressing, *inter alia*, issues concerning the procedural schedules in these matters. The status report included alternative "proposals" for extending the True-Up schedule. The Commission set 4:00 p.m. on Friday, March 6, 2009 as the deadline for responses to the proposals.

On March 5, 2009, Praxair, Inc., Midwest Energy Users' Association, Wal-Mart Stores, Inc., Sedalia Industrial Energy Users' Association, Ag Processing, Inc., the Office of the Public Counsel and the United States Department of Energy, National Nuclear Security Administration and Federal Executive Agencies (collectively "Movants") filed a motion for an extension of time to file their responses to the proposals. Movants claim that the proposals

involve complex issues, and that given the dearth of data presently available to them (involving, in part, information referenced in KCPL's and GMO's pleading concerning technical in-service criteria) they require more time to prepare their responses. Additionally, Movants note that because the only suggested changes in the procedural schedule involve True-Up, there is less urgency for a decision by the Commission on KCPL's and GMO's proposals.

The Movants request an extension until March 11, 2009 to file their responses. Movants further state that because the response and position of the Commission's Staff is critical to their evaluation, it would be preferable to allow Staff to respond first and allow Movants time to review, analyze and integrate Staff's position into their response.

The Commission finds Movants' request to be reasonable and shall grant it. No other party has requested an extension, and no extension is being granted to the other parties in this order. By having Staff respond by the original deadline of March 6, 2009, Movants will have the opportunity to consider Staff's position in their response.

## THE COMMISSION ORDERS THAT:

- 1. The "Motion for Extension of Time to Respond," filed by Midwest Energy Users' Association, Wal-Mart Stores, Inc., Sedalia Industrial Energy Users' Association, Ag Processing, Inc., the Office of the Public Counsel ("OPC") and the United States Department of Energy, National Nuclear Security Administration and Federal Executive Agencies, is hereby granted.
- The parties identified in ordered paragraph 1, shall file responses to the March
   2, 2009 pleading entitled "Status Report and Motion to Extend Period to Demonstrate

Compliance with Certain In-Service Criteria of Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company", no later than 4:00 p.m. on March 11, 2009.

2. This order shall become effective immediately upon issuance.
