Summit Natural Gas of Missouri (Summit) and contractors working for Summit have been installing natural gas pipelines in Camden County for over a year. Summit personnel and/or its contractors needed to determine the locations of county property and/or county right-of-way for possible installation of these pipelines on the county property and/or right-of-way. The following questions pertain to this pipeline construction.

1. In June 2013, if a utility was planning a project in Camden County in the area shown in Exhibit D (contained in the County's Second Response) and for that project the utility needed to get available information to show where the Camden County property and/or right-of-way may be located and contacted Camden County for that information, what information would the County have provided to the utility?

**Response:** As Camden County does not have information readily available to show where the Camden County property and/or right of way may be located, the utility would not have been provided any information by Camden County reflecting Camden County property and/or right of way.

2. Please provide a copy of the Tax District Map depicting the same area as shown in Exhibit D (contained in the County's Second Response).

3. Does the Tax District Map for the area shown in Exhibit D (contained in the County's Second Response) depict locations where there may be county property and/or right-of-way?

Please confirm that the disclaimer in Exhibit B is only found on the "Old Mapping Site".

**Response:** In June of 2013 a pop up disclaimer in Exhibit B is only found on the "old mapping site". Provided however, when a map is printed out on the GIS site, such as Exhibit D, the map contains a three sentence disclaimer at the bottom.
