ORDER RESETTING PROCEDURAL CONFERENCE AND SETTING OTHER PROCEDURAL DEADLINES

On March 30, 2018, Locustwood Associates filed a complaint with the Missouri Public Service Commission (“Commission”) against Spire Missouri d/b/a Spire. On July 25, 2018, the Commission’s Staff filed a motion to set a partial procedural schedule. In that motion Staff correctly points out that the case was suspended when Spire Missouri requested mediation on April 26, 2018.

In consideration of the additional time the case was suspended the Commission will grant Staff’s request and reset the procedural conference for a later date. The Commission will also grant additional time for Spire Missouri to file an answer and Staff to file a report and recommendation.

THE COMMISSION ORDERS THAT:

1. The procedural conference scheduled for Friday August 3, 2018, is cancelled and reset to October 3, 2018, at 10:00 a.m. in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This meeting will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. Any person

who needs additional accommodations to participate in the conference or hearing shall contact the Commission, not later than the day before the conference. Such contact shall be through the Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711. Any party may participate in the prehearing conference by telephone by dialing (573) 526-6119 or (866) 630-9354 at the start time of the conference.

2. Spire Missouri shall file an answer to Locustwood Associates' complaint no later than August 23, 2018.

3. The Staff of the Commission shall file a report and recommendation no later than September 7, 2018.

4. This order shall be effective when issued.
