2	JUDGE PRIDGIN: Good morning. We are on the
3	record. This is Prehearing Conference for File No.
4	GU-2020-0376. I'm Ron Pridgin. I'm the Regulatory Law
5	Judge assigned to preside over this prehearing. It's
6	being held via WebEx on July 7, 2020, and the time is
7	10:05 a.m.
8	I would like to get entries of appearance from
9	counsel, please, beginning with Spire Missouri?
10	MS. BOCKSTRUCK: Good morning. Appearing on
11	behalf of Spire Missouri is Goldie Bockstruck and Matt
12	Aplington, 700 Market Street, St. Louis, Missouri 63101.
13	JUDGE PRIDGIN: Ms. Bockstruck, thank you. On
14	behalf of the Staff of the Commission, please?
15	MS. MYERS: Yes, good morning. On behalf of
16	the Staff, Jamie Myers. Address is 200 Madison Street,
17	P.O. Box 360, Jefferson City, Missouri 65102.
18	JUDGE PRIDGIN: Ms. Myers, thank you. On
19	behalf of the Office of the Public Counsel, please?
20	MR. CALEB: Thank you, Judge. Caleb Hall
21	appearing on behalf of the Office of the Public Counsel.

24	JUDGE PRIDGIN: Mr. Hall, thank you. On

11	JUDGE PRIDGIN: Ms. Plescia, thank you. On
12	behalf of MECG, please? All right. I hear no
13	appearance for MECG. Have I overlooked anyone?
14	MR. BERLIN: Good morning, Judge. This is Bob
15	Berlin. David Woodsmall sent an email he's having
16	trouble getting in.
17	JUDGE PRIDGIN: Okay. I appreciate you
18	letting me know, Mr. Berlin. Thank you.
19	MR. OPITZ: Good morning, Judge. This is Tim
20	Opitz with Renew Missouri. I called in. I was having
21	some issues with the WebEx as well.
22	JUDGE PRIDGIN: Mr. Opitz, thank you. I'm
23	very sorry for folks having technical difficulties this
24	morning. Along those lines, I guess the on the record
25	portion of the prehearing will be over here shortly.

When I disconnect the call, the call should stay active; 1 2 but owing to the problems we've had so far this morning, do not be surprised if this calls gets disconnected 3 after I disconnect. So if that does happen, I would 5 encourage you to find alternative ways to talk. 6 I would normally ask for a proposed procedural 7 schedule in roughly a week or some sort of alternative 8 pleading. I'm not married to such a time frame. If you 9 think you need more time, that's certainly fine. Does 10 anyone have any, I guess any comments or thoughts on how 11 to go forward from here? 12 Please identify yourself before you talk so 13 the court reporter knows who's speaking. 14 MS. BOCKSTRUCK: Judge, this is Goldie 15 Bockstruck with Spire. I think a week is sufficient. 16 JUDGE PRIDGIN: Okay. Thank you, Ms. 17 Bockstruck. Anyone have I guess any objections to some 18 sort of schedule or pleading due in the next week or so? 19 Going once, going twice. MR. WOODSMALL: Your Honor, this is Dave 20 21 Woodsmall. I just want to let you know that I was able 22 to get through and I have no problems with the pleading 23 in a week. 24 JUDGE PRIDGIN: Okay, Mr. Woodsmall, thank you, and I'm sorry for any technical trouble you've had 25

this morning. I apologize. 1 MR. WOODSMALL: I think it was my fault. 2 3 Thank you. JUDGE PRIDGIN: You're welcome. 4 That's 5 probably all I have. I guess the only other thing I 6 would bring up, it probably makes no difference to you, 7 but there's a strong likelihood that this case will get 8 reassigned to another judge should it go to hearing. 9 That judge's schedule will be different from mine. So 10 that may pose a little bit of difficulty, but I suppose 11 we can cross that bridge when we come to it if we do at 12 all. I think that's all I have for the parties. 13 14 there anything else counsel has for me before we go off 15 the record? 16 MS. MYERS: Judge, this is just administrative 17 and this is Jamie Myers. I think if you're able to 18 assign me as host the call will stay active. I've had 19 that done in a couple prehearing conferences where the 20 judge went ahead and assigned the staff attorney as the 21 host to keep the call active. 22 JUDGE PRIDGIN: I'd be happy to do that if I 23 can figure out how. 24 Sure. And I called in with my MS. MYERS: telephone number. The last four digits are 1863, if 25
