On August 30, 2021, the Commission's Staff filed a motion asking the Commission to establish a working case to assist Staff in its review and consideration of the promulgation of a rule consistent with newly passed section 386.895, RSMo, which became effective on August 28, 2021. That statute directs the Commission to adopt rules for gas corporations to offer a voluntary renewable gas program.
