If you are the head of the Public Defenders office maybe you can help me. This incident happened in 2013 - Laclede Gas came to my house when I was not here and my wife was in bed asleep and they turned off our gas and started replacing the meter outside our home. They finally finished, after many errors/ mistakes at about 1:30am the next day.

The furnace was replaced about 6 years ago - but they destroyed my furnace and I now need a new one - The furnace was glowing red the first time it cycled on after they left - they came back and condemned my furnace in writing - about three times.
