NOTICE OF EXCLUSIONARY DATES

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Notice* in this matter hereby states:

1. William Wehrle (Complainant) filed this *Complaint* against Laclede Gas Company, now known as Spire, Inc. (Respondent) on January 22, 2013. Since the filing, Staff has conducted an investigation and submitted a *Report* on April 9, 2013; Complainant and Respondent had settlement discussions which did not come to fruition; the Commission issued an *Order* dismissing the Complaint on June 11, 2014; and Complainant filed a *Response* to that *Order* expressing that the matter remained unresolved on October 24, 2016. The Commission ordered Complainant to show cause why the *Complaint* should not be dismissed by August 20, 2018. Staff spoke to Complainant and filed a *Response to Order to Show Cause* on August 20, 2018, asking the Commission not to dismiss the *Complaint* and to permit Complainant a swift hearing in this matter. The Commission ordered Staff and Respondent to file exclusionary dates in this matter no later than September 4, 2018.

2. Staff was unable to reach Complainant prior to this filing, but has compiled the attached list of Staff's exclusionary dates entitled Appendix A.

WHEREFORE, Staff prays that the Commission will accept this *Notice of Exclusionary Dates*; issue an order for an evidentiary hearing, accordingly; and grant such other and further relief as the Commission considers just in the circumstances.
