## ORDER SETTING DEADLINE FOR SUBMISSION OF RESPONSE TO LETTER

Issue Date: October 25, 2016 Effective Date: October 25, 2016

On December 5, 2013, the Missouri Public Service Commission issued an *Order Directing Complainant to File a Statement*. The Commission directed Mr. Wehrle to inform the Commission if he still wished to have his furnace inspected by Laclede Gas Company or to proceed with an evidentiary hearing. Mr. Wehrle responded that he needed an additional thirty days to submit a response. On July 11, 2014, the Commission issued an *Order Dismissing Complaint* stating that more than five months had passed without a response from Mr. Wehrle, so the Commission was dismissing his complaint without prejudice. The July 11, 2014 order informed Mr. Wehrle that he could respond under the same case number if he wished to reopen the case.

On October 24, 2016, the Commission received a letter from Mr. Wehrle stating that previous attempts to contact legal counsel for Laclede Gas Company about a \$100 settlement offer as part of an agreed-to dismissal were unsuccessful. The Commission

will provide notice of Mr. Wehrle's letter and direct Laclede Gas Company to submit a response.

#### THE COMMISSION ORDERS THAT:

- 1. No later than November 30, 2016, Laclede Gas Company shall submit a response to Mr. Wehrle's letter.
- 2. The Commission's Data Center shall mail a copy of this order to Mr. Wehrle.
  - 3. This order shall be effective when issued.
