

Commission Rule 4 CSR 240-2.090(5) provides that “[f]ailure to appear at a prehearing conference without previously having secured a continuance shall constitute grounds for dismissal of ...the party’s complaint...unless good cause for the failure to appear is shown”. The Commission will not dismiss the complaint without giving Mr. Lane an opportunity to explain why he did not attend the prehearing conference.

Therefore, Mr. Lane shall file a pleading showing cause why his complaint should not be dismissed.

**THE COMMISSION ORDERS THAT:**

1. Johnny Lane shall file a pleading no later than October 10, 2017, showing cause why his complaint against Ameren Missouri should not be dismissed.
2. This order shall become effective upon issuance.

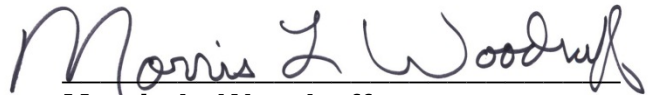
