STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and, for its *Recommendation*, hereby states as follows:

1. Staff reviewed the Recommended Report and Order issued by the Commission on March 23, 2022, in the above-captioned cause.
2. Staff noticed two typographical errors in the Recommended Report and Order, to wit:
 - a. On page 6, paragraph 10, the sentence reads, “Mr. Steins was felt upset and insulted...”. The word “was” is unnecessary; and
 - b. On page 9, paragraph G., the reference to the company in the second line should be to “Liberty,” and not to “MAWC.”
3. Staff recommends the Commission issue its Report and Order as written.

WHEREFORE, Staff respectfully asks that the Commission issue a Report and Order denying the Complainant’s complaint and overruling the Respondent’s motion to dismiss; and that it grant such other and further relief as is just in the circumstances.
