ORDER GRANTING EXTENSION OF TIME

On May 3, 2022, the Commission directed Spire Missouri Inc. to file its answer or a request for mediation in the above-captioned complaint no later than June 3, 2022. On June 2, 2022, Spire requested an extension of time until June 17, 2022, to make its filing. Spire explained that negotiations with the complainant have taken place and a settlement agreement has been reached. Spire requests additional time before filing its answer so that it may receive the settlement agreement from the complainant and a notice of dismissal may be filed resolving the complaint.

The Commission finds the request for extension reasonable and will grant it. Additionally, the Commission will extend the time for Staff to file its investigation report.

THE COMMISSION ORDERS THAT:

1. Spire's *Motion for Extension of Time* is granted.
2. If the complaint has not been settled by then, Spire shall file its answer to the complaint or request for mediation no later than June 17, 2022.

3. If the complaint has not been dismissed by June 17, 2022, Staff shall investigate this complaint and file a report with the Commission no later than July 15, 2022.

4. This order is effective when issued.
