**NOTICE OF REQUEST FOR MEDIATION
AND ORDER TO RESPOND**

On June 17, 2022, Spire Missouri, Inc. d/b/a Spire filed a *Request for Referral to Mediation or Motion for Extension of Time in the Alternative*, requesting that the Commission grant Spire's request for referral to mediation. In the alternative, Spire moved for an extension of time for Spire to file an answer – or to move for an extension of time to file an answer – to Complainant Bobby J. Armour's complaint. Spire stated that Mr. Armour has communicated that he has signed a settlement agreement and notice of dismissal of his complaint and mailed those documents to Spire, but Spire has not received those documents.

The Commission will toll all time limitations in this matter and order Mr. Armour to make a filing indicating whether he is willing participate in mediation.

THE COMMISSION ORDERS THAT:

1. All deadlines in this case are tolled until further order of this Commission.

2. If Complainant Bobby J. Armour has not filed a Notice of Dismissal by July 22, 2022, he shall file a response to this Order by that date. Mr. Armour shall state in his response whether he consents to participate in mediation, pursuant to 20 CSR 4240-2.125(2).

3. This order is effective when issued.
