## ORDER AND NOTICE

On January 10, 2006, Trigen-Kansas City Energy Corporation filed an Application requesting that the Commission grant it a Certificate of Convenience and Necessity to construct, install, own, operate, control, manage, and maintain a steam heat distribution service for the public in Kansas City, Jackson County, Missouri. Trigen requests a certificate for an expanded area adjacent to the area currently certificated in downtown Kansas City as further described in Appendices A and B attached to its application.

Applicant is a Delaware corporation with a principal office and place of business at 115 Grand Boulevard, Kansas City, Missouri 64106. Trigen filed a summary of the plans and specifications for the project. It also filed a list of ten persons residing in or who are landowners within the proposed service area. Trigen avers that the proposed service area does not have other steam heat suppliers at present.

The Commission has determined that the information officer of the Commission will make notice of this application available to the newspapers and other media serving Jackson County, Missouri, and to all members of the Missouri General Assembly representing Jackson County. Further, the Data Center of the Commission shall serve a copy of this order on the County Commissioners of Jackson County.

The Commission has also determined that proper persons should be allowed 30 days from the date of this order to file an application to intervene. The requirement of a hearing is met when an opportunity to be heard has been provided and no proper party has requested the opportunity to present evidence. In the event no proper person files an application to intervene in this matter, the Commission may proceed on the basis of the verified application and its attachments.

The Commission will further order the Staff of the Commission to file a responsive pleading to Trigen's application.

## IT IS THEREFORE ORDERED:

- That the Data Center of the Missouri Public Service Commission shall serve notice on the County Commission of Jackson County, Missouri.
- 2. That the information officer of the Missouri Public Service Commission shall send notice to the members of the Missouri General Assembly representing persons residing in Jackson County, Missouri, and to the media serving Jackson County, Missouri, as set out herein.
- 3. That any party wishing to request a hearing in this matter shall file an application no later than February 10, 2006, with:
