## ORDER SETTING PROCEDURAL CONFERENCE

Issue Date: July 19, 2018

Effective Date: July 19, 2018

On March 30, 2018, Locustwood Associates filed a complaint with the Missouri Public Service Commission ("Commission") against Spire Missouri d/b/a Spire. April 4, 2018, Notice of the formal complaint was issued and the Commission's Staff was ordered to file a report and recommendation by May 21, 2018. On May 22, 2018, an order appointing a mediator was issued, suspending the case under Commission Rule 4 CSR 240-2.125(2)(C).

The Commission finds that a procedural conference is now appropriate to discuss filing deadlines for a procedural schedule and a date for an evidentiary hearing. The parties or their representatives shall appear in person or by telephone at the conference, unless excused by the regulatory law judge. Additionally, the Commission's Staff will submit a report and recommendation as previously ordered.

### THE COMMISSION ORDERS THAT:

1. A procedural conference shall be held on Friday August 3, 2018, beginning at 10:00 a.m. in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson

City, Missouri. This meeting will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. Any person who needs additional accommodations to participate in the conference or hearing shall contact the Commission, not later than the day before the conference. Such contact shall be through the Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711. Any party may participate in the prehearing conference by telephone by dialing (573) 526-5622 or (866) 630-9348 at the start time of the conference.

2. The Staff of the Commission shall file a report and recommendation no later than August 2, 2018.

3. This order shall be effective when issued.
