**STATUS REPORT (April 19, 2022)**

The undersigned parties state the following to the Missouri Public Service Commission as their *Status Report (April 19, 2022)*:

1. At the parties' request, the Commission issued its *Order Suspending Procedural Schedule* on February 24, 2022. The parties have been directed to file a

stipulation and agreement, or a status report, by March 18, 2022, March 29, 2022, April 12, 2022, and April 19, 2022.

2. The parties report that the process of producing and filing a stipulation and agreement continues. The terms of a stipulation and agreement have been largely agreed to and the parties are working on the final edits.

3. The undersigned parties ask that the procedural schedule (including the discovery schedule) remain suspended and that the Commission further direct the parties to either file a stipulation and agreement or a status report no later than April 27, 2022.
