**NOTICE OF REQUEST FOR MEDIATION  
AND ORDER TO RESPOND**

On March 10, 2022, Spire Missouri Inc. d/b/a Spire filed a *Request for Mediation*.

In its request, Spire stated that it has sent certified mail through the United States Postal Service (USPS) to Complainant Robert Taylor, but he has not responded.

On March 15, 2022, the Staff of the Commission (Staff) filed *Staff's Request for Relief from Filing*, in which requested that the Commission relieve it from the obligation to file a proposed date for a procedural conference or, in the alternative, to file a joint proposed procedural schedule by the March 15<sup>th</sup> deadline set by the Commission in an order issued March 2, 2022.

The Commission will direct Mr. Taylor to respond to this notice, stating whether he is willing to participate in mediation. The Commission will relieve Staff from its filing obligation and will toll all previous deadlines set by the Commission in this case.

**THE COMMISSION ORDERS THAT:**

1. Complainant Ronald Taylor shall file a response to this Notice and Order no later than March 25, 2022. Mr. Taylor shall state in his response whether he consents to participate in mediation, pursuant to 20 CSR 4240-2.125(2).
2. All deadlines in this case, including the March 15<sup>th</sup> deadline for Staff to file a proposed date for a procedural conference or, in the alternative, to file a joint proposed procedural schedule, are tolled until further order of this Commission.
3. The Data Center of the Commission shall mail of copy of this Notice and Order to Mr. Taylor via USPS first class mail.
4. This order shall be effective when issued.
