On September 28, Respondent, Spire Missouri Inc. (“Spire” or “the Company”) and Complainant, Mr. Charles A. Harter, jointly filed a motion asking the Commission to stay the procedural schedule set by the Commission, and postpone the requirement for Spire to file an answer or a joint status update until November 14. More than ten days have passed since the the joint motion was filed, and no party has opposed that motion.

The joint motion is reasonable, and the Commission will grant it. The Commission will also stay the requirement that Staff file its investigation report by October 28, and direct Staff to file its investigation report no later than November 29.

THE COMMISSION ORDERS THAT:

1. The Joint Motion to Stay Proceeding filed by Spire and Mr. Charles A. Harter is granted.
2. Spire shall file an answer, or the parties shall file a joint status update, no later than November 14, 2022.
3. The Commission's order for Staff to file its investigation report by October 29 is stayed. Staff shall file its investigation report no later than November 29, 2022.
4. This order shall be effective when issued.
