## ORDER EXTENDING TIME FOR STATUS REPORT

The Commission granted a motion to suspend the filing of a proposed procedural schedule in this case due to a pending settlement agreement in the general rate case of Union Electric Company d/b/a Ameren Missouri, File No. ER-2022-0337. That agreement purportedly may resolve the issue raised in these two complaints.
