- 1 PROCEEDINGS
- 2 JUDGE JORDAN: I have five minutes after
- 3 nine now, and so we will go on the record in Case
- 4 No. GC-2009-0236, which is Sam Waheed vs. AmerenUE. I'm
- 5 Daniel Jordan. I'm a Regulatory Law Judge with the
- 6 Missouri Public Service Commission.
- 7 We'll start with entries of appearances and
- 8 introductions of client representatives, and I'll begin
- 9 with our Complainant, Mr. Waheed. Will you please state
- 10 your name and spell it for our court reporter.
- MR. WAHEED: Sure. Sam Waheed, S-a-m,
- 12 W-a-h-e-e-d.
- 13 JUDGE JORDAN: Thank you. And who all is
- 14 here for AmerenUE?
- MS. TATRO: Wendy Tatro, 1901 Chouteau
- 16 Avenue, St. Louis, Missouri, on behalf of AmerenUE. I
- 17 have two company representatives with me today, Cathy Hart
- 18 in the customer service area and Richard Grimpo, I believe
- 19 is on, in the metering area.
- 20 JUDGE JORDAN: Can you give us spellings
- 21 for your client representatives' names, please?
- 22 MS. TATRO: Sure. Cathy, C-a-t-h-y, Hart,
- 23 H-a-r-t. Richard Grimpo, G-r-i-m-p-o.
- JUDGE JORDAN: Thank you.
- 25 MR. KNOLL: And this is Alex Knoll for

- 1 AmerenUE, 111 South Ninth Street, Suite 200, Columbia,
- 2 Missouri 65201.
- JUDGE JORDAN: All right. Anyone else
- 4 there for AmerenUE? Okay. Thank you very much.
- 5 Entry of appearance from Staff, please.
- 6 MR. BERLIN: Appearing on behalf of the
- 7 Staff of the Missouri Public Service Commission, Bob
- 8 Berlin, Post Office Box 360, Jefferson City, Missouri
- 9 65102, and with me is Marilyn Doerhoff from our customer
- 10 service department.
- 11 JUDGE JORDAN: All right. Thank you very
- 12 much. And from the Office of the Public Counsel?
- 13 MR. POSTON: Thank you. Marc Poston
- 14 appearing for the Office of the Public Counsel, P.O.
- 15 Box 2230, Jefferson City, Missouri 65102.
- 16 JUDGE JORDAN: All right. Anyone else
- 17 there from the Office of Public Counsel?
- MR. POSTON: No. Just me.
- 19 JUDGE JORDAN: Okay. Thank you very much.
- 20 Well, first I'll describe what we're going to do in our
- 21 prehearing conference. As I mentioned, we are on the
- 22 record. We have a reporter transcribing what we say
- 23 today, and -- oh, is there someone else on the line
- 24 joining us?
- 25 (The prehearing conference was interrupted

1 by other callers on the conference call.)

- 2 (AN OFF-THE-RECORD DISCUSSION WAS HELD.)
- 3 JUDGE JORDAN: Here's what we're doing. We
- 4 are on the record. I want to discuss procedure that we
- 5 would have if we go to hearing, which of course you don't
- 6 have to if you settle, and we can also discuss the
- 7 substance of the issues that are before us.
- 8 And when that part is done, since we have
- 9 everyone on the line, that's a good opportunity for the
- 10 parties to talk without me being around and without the
- 11 court reporter and off the record, so the parties may feel
- 12 comfortable sharing information that's sensitive otherwise
- 13 and can do so outside my hearing.
- 14 And let me mention also that if there
- 15 remains the possibility of settlement and you think it
- 16 would be helpful, the Public Service Commission does offer
- 17 mediation services so that you can have a neutral third
- 18 party come in and help you work something out.
- 19 So that's what we'll do today. We'll have
- 20 an on-the-record part and then an off-the-record part.
- 21 Now, I want to -- any questions so far?
- MS. TATRO: None here, your Honor.
- JUDGE JORDAN: Okay. Then I'll talk about
- 24 the hearing procedure a little bit just so everyone knows
- 25 what the ground rules will be if we go to hearing.

1 It is an evidentiary hearing. That is, the
```

- 2 things that would come to me to build a record on which
- 3 the decision would be made would have to meet certain
- 4 standards of evidence. I'll give you a couple of statutes
- 5 that are probably the most important in this. I'll give
- 6 you the citations. They are Sections 536.070.
- 7 MR. WAHEED: Sir, can you repeat that?
- JUDGE JORDAN: Yes, I can. It's 536.070.
- 9 And the other section is Section 490.065, and that's
- 10 something to look at in case there are accounting issues
- 11 here, which probably everyone in the room is more adept
- 12 with than I am, but in order for me to understand them,
- 13 you might want to take a look at that section.
- 14 That will help everyone get such evidence into the record.
- 15 If we do go to a hearing, the burden of
- 16 proof will be on the Complainant, on his issues, to show
- 17 that AmerenUE has done something wrong. The order of
- 18 proof would be -- and this is something like what you see
- 19 when you watch TV and you see trials. Order of proof
- 20 would be the Complainant, followed by AmerenUE, followed
- 21 by Staff.
- When the hearing is over, the court
- 23 reporter would -- hello?
- 24 (The prehearing conference was interrupted
- 25 by the conference operator.)

- JUDGE JORDAN: So anyway, yeah. The
- 3 reporter will prepare a transcript, and then you can have
- 4 a copy of the transcript. You'd have to pay for that.
- 5 But then you have the chance to prepare written argument
- 6 as well in which you look at the transcript and you can
- 7 cite that as you develop a brief, basically. That's how
- 8 that works.
- 9 And then when all that stuff is in, I will
- 10 prepare sort of a recommended decision for the Commission,
- 11 and the Commission is the final decision-maker here. I
- 12 give them my take on it, and then they are free to make up
- 13 their mind as they see fit.
- 14 Are there any questions so far as to how I
- 15 see us proceeding if we go to hearing?
- 16 (No response.)
- 17 JUDGE JORDAN: I don't hear any questions
- 18 from anyone. Okay. Well, here's something I want to
- 19 mention in regard to this case in particular as we get
- 20 into some of the issues that remain, and that is I want to
- 21 compliment everyone for the degree of civility and
- 22 professionalism that they have brought to this process so
- 23 far.
- 24 Candidly, I'm not used to that in my
- 25 government work, but it seems like everyone has looked at

- 1 a problem in billing and looked at it seriously and found
- 2 some errors and done their best to correct them. If I
- 3 understand, the only thing that's left is a number, a
- 4 quantity called a constant. Am I correct about that?
- 5 MR. WAHEED: Yes, sir.
- 6 JUDGE JORDAN: Okay. Maybe you can
- 7 educate, someone can educate me as to what the constant
- 8 is, and maybe we can figure out what it's supposed to be.
- 9 Who would like to start?
- 10 MS. TATRO: This is Wendy Tatro with
- 11 AmerenUE. I guess I would have either Cathy or Richard
- 12 talk about how constant works.
- JUDGE JORDAN: I appreciate that, yes. If
- 14 you can enlighten me, please do.
- 15 MR. GRIMPO: I'll take a stab at it. The
- 16 constant works as applied because when a meter -- a gas
- 17 meter is normally set to measure gas at seven inches of
- 18 water power, which is a unit of pressure. And when
- 19 pressure greater than that standard is run through a
- 20 meter, then we have to apply a constant to billing to
- 21 compensate for the greater amount of gas that goes through
- 22 the meter because of the high pressure.
- JUDGE JORDAN: Okay. So the constant is a
- 24 sort of a factor in the billing, is that correct, that
- 25 describes how much more gas than usual is going through?

1 Would that be a good way to say it?
```

- 2 MR. GRIMPO: Yes.
- JUDGE JORDAN: Okay. Good for me. I'm
- 4 learning something today. I appreciate that. And
- 5 depending on what that number is, I guess that affects
- 6 what the bill is; is that correct?
- 7 MR. GRIMPO: Yes.
- JUDGE JORDAN: Okay. All right.
- 9 Mr. Waheed, does that meet your understanding?
- 10 MR. WAHEED: That's fine, sir, yes.
- 11 JUDGE JORDAN: All right. And if I recall
- 12 the state of things, the pleadings, the exchanges that
- 13 we've had back and forth, really the -- if I understand it
- 14 correctly, and anyone can feel free to correct me on this,
- 15 the only question that Mr. Waheed has remaining is where
- 16 does that number come from. Is that fairly accurate?
- 17 MR. WAHEED: Yes. They kept changing it.
- 18 They changed it twice. And my question is, in October
- 19 when they said they change the meter, they changed -- they
- 20 said that it would be 1.656, and in January they said no,
- 21 they made a mistake, it's now 1.317. If you look at the
- 22 percentage from 1.317 to 1.657, it's almost over
- 23 30 percent difference coming up in the point values, and
- that's huge.
- 25 My next question is, when my neighbor

- 1 called, because our meter is located right where my
- 2 neighbor's property is, his gas meter was leaking gas and
- 3 mine was, too, because when the Ameren employee came in,
- 4 they did saw it and I saw it, too. Because it's not ever
- 5 at our property, we don't go all the time over there.
- 6 It's a closed property. It used to be a restaurant and a
- 7 lounge. Used to be part of the hotel, but eight years ago
- 8 they separated it and sold separate. So I need to know,
- 9 did they change my neighbor's constant, too? Was his
- 10 constant was changed?
- 11 And the other question I have is, in
- 12 their -- they sent me, Union Electric Company gas service,
- 13 they said that whenever a gas meter is registered gas
- 14 because of leak in the meter or in the union connection on
- 15 the outlet side of the meter or the connection between
- 16 company and customer piping, whichever is applicable, an
- 17 estimate based upon the period of necessary referred to
- 18 above will be made off the registration which has been
- 19 produced by the leakage and a corresponding credit will be
- 20 allowed to customer.
- 21 There was no credit given to us in my bill, and -- and we
- 22 don't know how long it's been leaking.
- 23 Second, I have a very important point. If
- 24 you look at G on the same Union Electric Company gas
- 25 service agreement, it says no correction to metering data

1 for meter error shall extend beyond the in-service date of

- 2 the meter discovered to be in error.
- 3 That means that when the last time meter
- 4 was checked, there shouldn't be -- they cannot charge me
- 5 from that date. And last time AmerenUE came in was
- 6 July -- May 27th, '08, and the gas was shut down. You
- 7 can -- in my initial complaint I also mentioned the gas
- 8 was shut down on May 27, '08. How come they are going
- 9 back two years to bill me all that?
- 10 And that is my biggest concern is because
- 11 in your agreement it says that when the meter -- if they
- 12 service the meter or they discovered any error, they
- 13 cannot go beyond that limit, and why I was being charged
- 14 for past 24 months.
- 15 JUDGE JORDAN: Are you done? I don't want
- 16 to interrupt you.
- MR. WAHEED: Yes, sir.
- 18 JUDGE JORDAN: So if I can summarize what I
- 19 understand your issues to be so far, you have a question
- about the constant, yes.
- MR. WAHEED: Yes.
- 22 JUDGE JORDAN: But you also want to know if
- 23 the same is applied to your neighbor; is that correct?
- MR. WAHEED: Right, sir.
- 25 JUDGE JORDAN: You also want to make sure

- 1 that you've gotten the proper amount of credit?
- 2 MR. WAHEED: Right.
- JUDGE JORDAN: And then finally your last
- 4 issue had to do with the period of going back, two-year
- 5 period?
- 6 MR. WAHEED: Yes.
- 7 JUDGE JORDAN: Okay. Well, it sounds like
- 8 we're getting more into the substantive issues here. This
- 9 may be a good time for me to make my exit so that the
- 10 parties can speak freely and frankly without tainting the
- 11 evidentiary record by having me hear things they don't
- 12 want me to hear off the record.
- Does AmerenUE have anything more that it
- 14 would like to tell me or ask me before the reporter and I
- 15 make our exit?
- MS. TATRO: We do not. Thank you.
- JUDGE JORDAN: Okay. Staff, anything more
- 18 for me?
- MR. BERLIN: No.
- 20 JUDGE JORDAN: And Office of the Public
- 21 Counsel?
- MR. POSTON: No. Thank you.
- JUDGE JORDAN: Well, I thank you very much
- 24 for your attention and for your patience during this call
- 25 and for staying with me while we overcame technical

difficulties. And I think if no one else has anything for

me, which they appear not to have, we will go off the
 2
    record. Thank you very much.
