MOTION FOR EXPEDITED TREATMENT

COMES NOW Summit Natural Gas of Missouri, Inc. ("SNGMO" or the "Company"), and, in accordance with Missouri Public Service Commission (Commission) Rule 20 CSR 4240-2.080(14), moves the Commission for expedited treatment of SNGMO's tariff sheets filed on May 22, 2020:

- 1. On May 6, 2020, the Commission issued an *Order Granting Certificates of Convenience and Necessity* in the case. Among other things, the Order directs that "Summit shall update its tariffs to incorporate the requested sections for Laclede County and Webster County."
- 2. Concurrently, with the filing of this Motion, SNGMO has filed the following tariff sheets consistent with the Commission's *Order Granting Certificate of Convenience and Necessity*:
 - P.S.C. MO No. 3, 2nd Revised Sheet No. 3C, Cancels 1st Revised Sheet No. 3C;
 - P.S.C. MO No. 3, 1st Revised Sheet No. 4E, Cancels Original Sheet No. 4E; and,
 - P.S.C. MO No. 3, 2nd Revised Sheet No. 4L, Cancels 1st Revised Sheet No. 4L.

These tariff sheets carry proposed effective dates of June 21, 2020 (30 days), and have been assigned Tracking No. YG-2020-0205.

3. SNGMO hereby seeks the Commission's order allowing the proposed tariff sheets to go into effect on less than thirty days notice.

4. A grant of this motion will further the public interest. As indicated in the

underlying Application, the requested CCNs are a part of a system upgrade designed to provide a

long-term solution to the pressure and capacity issues encountered on the Rogersville system. It

is important for timely completion of this project that construction within the certificated areas

continue at the earliest possible time.

5. Pursuant to Commission Rule 20 CSR 4240-2.080(14), SNGMO submits that no

harm will result from the granting of this Motion, as the revised tariff sheets are in conformity

with the Commission Order. SNGMO also states that this Motion is being filed as quickly as

possible after the Company has prepared the revised tariff sheets.

WHEREFORE, for the foregoing reasons, SNGMO respectfully requests the

Commission grant this Motion for Expedited Treatment and approve SNGMO's proposed tariff

sheets identified by Tracking No. YG-2020-0205, to be effective as of June 5, 2020.
