- 1. Ameren Missouri and Co-Mo have no objection to answering territorial agreement boundary/service area questions at the September 15, 2022 Local Public Hearing.
- 2. In order to do so, Applicants suggest that the Commission establish a separate breakout room using the breakout room function in Webex. This would allow any person logging onto the Commission's Webex session for the Local Public Hearing to choose to enter the breakout room and ask Applicant representatives questions regarding the location of their property in relation to the areas allocated to each of Ameren Missouri and Co-Mo under the Territorial Agreement. Applicants suggest that the Webex session and breakout room option become available at 5:30 p.m. on September 15 so that persons desiring to ask questions about the service areas and their land could begin to do so in advance of the questions and answers session, if they so desire. As noted, Applicants will have representatives with access to the pertinent real estate information available to answer any landowner's question respecting where the landowner's land is situated vis-à-vis the territories at issue.

WHEREFORE, Applicants respectfully suggest that the Webex breakout room process outlined above be implemented to fully address the request in Staff's above-referenced motion.
