On January 20, 2016, the Commission issued an Order Regarding Fuel Adjustment Clause Tariff ("Order"), which rejected the tariff sheets previously submitted by Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") and authorized Ameren Missouri to file new tariff sheets in compliance with its Order. On January 21, 2016, Ameren Missouri filed a revised tariff sheet and a *Motion for Expedited Treatment* requesting that the tariff sheet become effective on January 27, 2016. The tariff sheet carries an effective date of February 20, 2016, but Ameren Missouri's motion for expedited treatment asks the Commission to approve the tariff revisions to take effect on less than thirty days' notice so that customers may receive a rate decrease as soon as possible.

The Commission ordered that any party wishing to respond to Ameren Missouri's motion for expedited approval of its tariff do so no later than January 25, 2016. The Commission also ordered its Staff to file a recommendation by that date. On January 25, 2016, Commission's Staff filed its recommendation advising the Commission to approve the tariff to be effective on January 27, 2016, as requested. No other party has filed an objection or response regarding the motion for expedited treatment or the tariff.

The Commission finds that Ameren Missouri has demonstrated good cause to make the tariff effective on less than thirty days' notice, since doing so will allow a rate decrease to go into effect for customers as soon as possible. Based on its independent and impartial review of Staff's recommendation and the company's unopposed motion, the Commission concludes that the submitted tariff should be approved on less than thirty days' notice.

THE COMMISSION ORDERS THAT:

The proposed tariff sheet submitted under Tariff No. YE-2016-0187 by Union
Electric Company d/b/a Ameren Missouri is approved, effective on and after January 27,
2016. The specific tariff sheet approved is:
