## ORDER DIRECTING SUBMISSION OF PROPOSED NOTICE OF LOCAL PUBLIC HEARINGS

On August 11, 2016, various parties filed a recommended schedule of local public hearings regarding Ameren Missouri's request for a rate increase. The Commission will finalize the proposed hearing dates and confirm locations before issuing an order formally scheduling the local public hearings. As part of that scheduling order, the Commission will direct Ameren Missouri to provide specific notice of the local public hearings to its customers. To that end, the Commission will direct Staff to consult with the other parties to agree on and file the language they would like the Commission to use in that notice.

### THE COMMISSION ORDERS THAT:

1. No later than August 25, 2016, Staff shall file proposed language to be included in the notice of the local public hearings to be provided by Ameren Missouri to its customers.

2. This order shall be effective when issued.
