### STAFF RECOMMENDATION TO APPROVE REVISED TARIFF SHEET AND MOTION FOR EXPEDITED TREATMENT

COMES NOW Staff of the Missouri Public Service Commission, by and through counsel, and submits its Recommendation to the Missouri Public Service Commission ("Commission") recommending that the Commission issue an order approving Revised Tariff Sheet No. 49O as filed by Kansas City Power & Light Company ("KCPL") on July 22, 2016 bearing an effective date of August 1, 2016. In support Staff states as follows:

- 1. On June 1, 2016, KCPL filed Tariff Sheet Nos. 49G, 49H, and 49I for the purpose of modifying the Company's DSIM under the Missouri Energy Efficiency Investment Act ("MEEIA"). KCPL filed Tariff Sheet 49O to implement new DSIM rates incorporating the modifications sought in Sheet Nos. 49G, 49h and 49I. All sheets were assigned Tariff Tracking No. JE-2016-0343. On July 1, 2016, Staff filed its recommendation regarding KCPL's DSIM rider tariff, advising the Commission to reject KCPL's tariff sheets assigned Tariff Tracking No. JE-2016-0343.
- 2. On July 20, 2016, the Commission entered its order rejecting KCPL's tariff sheets (Tariff Tracking No. JE-2016-0343) and directed KCPL to file a corrected First Revised Sheet No. 49O that includes DSIM rates which are calculated pursuant to the existing DSIM Rider that includes the Cycle 1 under-billed amount and carrying costs attributed to the under-billed amount resulting from KCPL's calculation error

related to Cycle 1 program costs. On July 22, 2016, KCPL filed its Revised Sheet No. 49O, assigned Tariff Tracking No. YE-2017-0017, along with a motion for expedited consideration and approval on less than thirty days' notice. That same day the Commission issued its Order Directing Filing ordering the Staff to respond no later than noon, July 25, 2016.

3. The Commission Staff's Tariff and Rate Design Department has reviewed the filed revised tariff sheet and recommends the Commission issue an order approving it as filed on July 22<sup>nd</sup> for service on and after August 1, 2016 and further recommends the Commission approve KCPL's motion for expedited treatment on less than 30 days' notice for good cause shown. Staff is of the opinion good cause exists because the August 1 effective date maintains the six month adjustment intervals integral to the operation of the DSIM. See Staff's Memorandum attached hereto as Appendix A and incorporated herein.

WHEREFORE, for the reasons discussed above and further explained in Staff's Memorandum, Staff recommends the Commission issue an order approving the following tariff sheet as filed by KCPL on July 22, 2016 bearing an effective date of August 1, 2016:

#### **Background**
