#### ORDER APPROVING FUEL ADJUSTMENT TRUE-UP

Issue Date: September 14, 2016 Effective Date: September 23, 2016

Union Electric Company d/b/a Ameren Missouri ("the company") filed an application and a supporting testimony. Staff filed a recommendation in favor of the application. No party has filed a response to that recommendation within the time provided by regulation.

The application seeks the Commission's approval of amounts related to the company's fuel adjustment clause ("FAC"). Specifically, the amounts relate to the company's Accumulation Period 19 (February 1, 2015 through May 31, 2015) and Recovery Period 19 (October 2015 through May 2016). The Recovery Period 19 amounts are a component of a related FAC tariff pending in another case.

The application alleges a \$75,611 over-recovery during Recovery Period 19. Staff agrees and recommends that the Commission approve the application. On the basis of

those verified and uncontested filings, the Commission independently finds and concludes that the application conforms to the applicable statutes, regulations, and tariffs. Therefore, the Commission will approve the application. The related FAC tariff's proposed effective date coincides with the company's cycles of accumulation and recovery, which constitutes good cause for an effective date less than 10 days from the date of this order.<sup>7</sup>

#### THE COMMISSION ORDERS THAT:

- 1. The application described in the body of this order is approved.
- 2. This order shall be effective on September 23, 2016.
- 3. This file shall close on September 26, 2016.
