ORDER SETTING PROCEDURAL SCHEDULE

Issue Date: September 5, 2018

Effective Date: September 5, 2018

On August 21, 2018, the Commission ordered all parties to file their exclusionary dates for the purposes of setting this case for an evidentiary hearing. On September 4, 2018, the Missouri Public Service Commission Staff ("Staff") and Spire Missouri, Inc., ("Company") filed their exclusionary dates. On September 4, 2018, Staff filed notice that Complainant had contacted Staff, had advised Staff that he had no exclusionary dates, and had requested that the evidentiary hearing occur in Jefferson City, Missouri. Accordingly, the Commission will enter an order setting the procedural schedule.

The Commission recommends that Mr. Wehrle review the Commission's handbook on representing oneself at the Commission. The handbook, entitled "Representing Yourself Before the PSC" can be found at <http://www.psc.mo.gov/file-a-complaint>.¹

¹ This procedural schedule does provide for pre-filed testimony. If the parties intend to file testimony, they must inform the Commission of their intent to do so.

THE COMMISSION ORDERS THAT:

1. The procedural schedule shall be as follows:

Parties shall file List of Issues, Position Statements, and Identification of Witnesses	-	November 9, 2018
Evidentiary Hearing	-	November 16, 2018 10:00 a.m.

2. All witnesses shall be presented live and be subject to cross-examination.

3. The Order of witnesses and cross-examination shall be as follows:

- Complainant's witnesses
 - Company cross-examination
 - Staff cross-examination
- The Company's witnesses
 - Complainant's cross-examination
 - Staff cross-examination
- The Staff's witnesses
 - Complainant's cross-examination
 - Company cross-examination

4. The need for briefs shall be addressed at the conclusion of the evidentiary hearing.

5. Any issue not listed in the List of Issues and any witness not listed in the List of Witnesses as herein ordered, will not be considered by the Commission

6. The hearing will be held at the Commission's offices in the Governor Office Building, Room 310, 200 Madison Street, Jefferson City, Missouri, a facility that meets the accessibility standards of the Americans with Disabilities Act (ADA). Any person who

7. All parties shall make their witnesses, if any, available for examination the day of the hearing in person.
