ORDER EXTENDING TIME

On October 4, 2018, Missouri Propane Gas Association and Summit Natural Gas of Missouri, Inc., jointly filed a motion asking the Commission to Suspend the Procedural Schedule and therein stated that they have reached an agreement in principle to resolve all remaining issues and are drafting a Stipulation and Agreement.

On October 5, the Commission suspended the Procedural Schedule and directed the parties to file a status report by November 5. On November 5, all parties jointly filed a *Case Status Report* indicating that settlement discussions are ongoing and the parties are reviewing the terms of a draft Stipulation and Agreement. The parties expressed belief that an additional thirty day extension to continue discussions would be beneficial. The Commission will extend the deadline for the parties to file either a Stipulation and Agreement or Status Update.

THE COMMISSION ORDERS THAT:

1. The parties are directed to file a case update with the Commission no later than December 5, 2018, if no stipulation or settlement has been filed by that date.
2. This order shall be effective when issued.
