ORDER DENYING MOTION FOR PARTIAL SUMMARY DISPOSITION

Issue Date: November 9 2016 Effective Date: November 9, 2016

The Missouri Propone Gas Association ("MPGA") filed a complaint against Summit Natural Gas of Missouri, Inc. ("Summit") alleging Summit violated the Commission's September 3, 2014 Order Approving the Partial Stipulation and Agreement as to Duel Fuel Conversion of Appliances ("Agreement") in File No. GR-2014-0086. MPGA is a non-profit trade association representing members who sell propane or propane appliances and equipment in Missouri. Summit is a "gas corporation" and "public utility" pursuant to Section 386.020, RSMo (Cum.Supp. 2013). MPGA alleges Summit violated the terms of the Agreement by converting unvented gas-heating products from propane to natural gas in violation of the manufacturer's specifications. The unvented gas-heating products at issue include gas fireplaces and room heaters.

MPGA filed a Motion for Partial Summary Disposition asserting that there is no genuine issue as to any material fact. In its legal memorandum supporting its motion, MPGA states the only question before the Commission involves the interpretation of the language in paragraph 1 of the Agreement, which states as follows:

"For converting appliances from propane to natural gas, SNGMO² agrees to follow all applicable national and local codes and manufacturers' specifications relating to the conversion of appliances." (Emphasis added).

In its Response of Summit Natural Gas of Missouri, Inc. in Opposition to Motion for Partial Summary Determination, Summit acknowledges that it converted four unvented gas-heating products from propane to natural gas, but disagrees with MPGA's framing of the issue. MPGA argues that each of the owner's manuals for the products converted by Summit state that the products shall not be converted from one fuel to another. MPGA's position is that the manufacturers' specifications, as found in the owner's manual and product rating plates, clearly prohibit conversion to different gas types. Summit challenges this interpretation and asserts that conversions were contemplated in the Agreement and the question presented is whether Summit followed all applicable manufactures' specifications relating to the conversion of appliances. Summit disagrees with MPGA's claim that the owner's manuals are the manufactures' specifications contemplated in the Agreement.

Pursuant to Commission Rule 4 CSR 240-2.117(1)(E), the Commission may grant a motion for summary determination if:

the pleadings, testimony, discovery, affidavits, and memoranda on file show that there is no genuine issue as to any material fact, that any party is entitled to relief as a matter of law as to all or any part of the case, and the commission determines it is in the public interest.

A motion for summary determination is only proper where the moving party establishes that there is no genuine issue as to any material fact. Summit's response to MPGA's motion demonstrates the existence of a genuine issue as to material facts. Summit argues that MPGA's motion raises at least six questions of material fact, including whether the statements in the owner's manuals constitute "manufacturers' specifications relating to the conversion of appliances" when applied to natural gas suppliers. Summit also challenges whether the affidavit of Mr. Brian Brooks³ that was attached in support of MPGA's motion demonstrates a requisite level of expertise to support MPGA's claims.

At this time, based solely on the pleadings and the supporting documentation submitted by the parties, the Commission is unable to make a factual determination as to what are the applicable manufacturers' specifications relating to the conversion of appliances. Therefore, the Commission will deny MPGA's *Motion for Partial Summary Disposition*.

THE COMMISSION ORDERS THAT:

1. Missouri Propane Gas Association's *Motion for Partial Summary Disposition* is denied.
