**ORDER DIRECTING FILING**

On April 27, 2016<sup>1</sup>, the Office of the Public Counsel (“OPC”) filed a complaint with the Missouri Public Service Commission against Laclede Gas Company (“Laclede”) and Missouri Gas Energy (“MGE”) (collectively, “Respondents”). The complaint alleges that Respondent’s rates are excessive and should be reduced.

On September 29, OPC filed a Motion to Stay Proceedings. In that motion, OPC explains that its discovery in this case leads it to believe that staying this complaint would be in the public interest. OPC believes a general rate case, which Laclede plans to file by April, 2017, is the better way to address the issues.


