## ORDER SETTING PROCEDURAL CONFERENCE

On June 23, 2017, David Apted filed a complaint with the Missouri Public Service Commission ("Commission") against Laclede Gas Company. On August 15, 2017, the Commission's Staff filed a *Staff Report*.
