ORDER SETTING PROCEDURAL CONFERENCE

On June 23, 2017, David Apted filed a complaint with the Missouri Public Service Commission ("Commission") against Laclede Gas Company. On August 15, 2017, the Commission's Staff filed a *Staff Report*. The Commission finds that a procedural conference is now appropriate to discuss filing deadlines for a procedural schedule and a date for an evidentiary hearing. The parties or their representatives shall appear in person or by telephone at the conference, unless excused by the regulatory law judge. Parties wishing to appear by telephone will be provided with a telephone conference number.

THE COMMISSION ORDERS THAT:

1. A procedural conference shall be held on Thursday August 2, 2018, beginning at 2:30 p.m. in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This meeting will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. Anyone needing additional accommodations to
