**ORDER DIRECTING FILING REGARDING STAFF’S MOTION TO  
CHANGE STATUS OF COMPLAINT AND TO DISMISS**

On May 16, 2018, Brett Felber (“Complainant”) filed a complaint with the Missouri Public Service Commission (“Commission”) against Spire Missouri, Inc. d/b/a Spire. On June 11, 2018, the Commission’s Staff filed a motion to change the status of this case as a small formal complaint in order to permit Staff to seek dismissal of the case for a number of reasons. The Commission will direct the Complainant to respond to Staff’s motion and provide an opportunity for other parties to comment on Staff’s motion. Staff also requests that the filing requirements established by order of May 17, 2018 for Spire to answer the complaint and Staff to submit a report be suspended while the Complainant responds to Staff’s motion. Since the requested filing suspension would promote administrative economy, the Commission finds this request to be reasonable and will grant it.

**THE COMMISSION ORDERS THAT:**

1. No later than June 21, 2018, Brett Felber shall file a response to Staff's Motion to Change Status of Complaint and To Dismiss, which was filed on June 11, 2018.
2. Any other party wishing to respond or comment on Staff's Motion to Change Status of Complaint and To Dismiss shall file its response no later than June 21, 2018.
3. The filing requirements established by the Commission's order of May 17, 2018 for Spire to answer the complaint and Staff to submit a report are suspended until further order of the Commission.
4. This order shall be effective when issued.
