12 The court reporter has already been given my contact  
13 information.

14 JUDGE: Mr. Hall, thank you. Anyone else

16 none, is there anyone who wishes to testify this  
17 evening? Going once, going twice. Commissioner  
18 Kenney, any closing remarks?

19 MR. KENNEY: No. Thank you.

20 JUDGE: Anything from Counsel? All right.  
21 The folks who showed up this evening, thank you very  
22 much. I appreciate you being here. That concludes  
23 the local public hearing. We are off the record.


