**ORDER DIRECTING FILING**

The Commission issued its Order Denying Rehearing in this matter on February 1, 2017, effective that same date. The Commission directed the Staff of the Missouri Public Service Commission (Staff) to file a reconciliation that complies with Subsection 386.420.4, RSMo, no later than February 24, 2017. Staff responded to that order indicating that due to the nature of the issues and the lack of specific information in the record, it was unable to comply with the order.

A teleconference was held at 10:30 a.m. on February 24, 2017, at which the parties, represented by their counsel, appeared. A discussion regarding the nature of the reconciliation was held. No agreement was reached as to a specific quantification and the Senior Regulatory Law Judge directed that the parties each file their suggested reconciliation amount, or other information they suggest be put in the Commission's reconciliation. Therefore, this order memorializes that direction and sets a deadline for the filing.

**THE COMMISSION ORDERS THAT:**

1. The parties shall each file the information required for the Commission to complete its reconciliation in compliance with Section 386.420.4, RSMo, or other information that the Commission shall include no later than 12:00 p.m., February 27, 2017.
2. The parties may submit written statements with regard to the other parties' filings no later than 5:00 p.m., February 28, 2017.
3. Other procedural deadlines not included in this order are rescinded.
4. This order shall be effective when issued.
