## ORDER DIRECTING FILING

Issue Date: September 21, 2021

Effective Date: September 21, 2021

On September 1, 2021,<sup>1</sup> Spire Missouri Inc. d/b/a Spire Missouri East and Spire Missouri West (Spire) filed an Application to Update its Weather Normalization Adjustment Rider (WNAR) per sheets with Tariff Tracking Numbers JG-2022-0047 and JG-2022-0048. The tariff sheets filed under JG-2022-0047 and JG-2022-0048 bear an October 1, 2021, effective date. On September 10, the Commission's Staff (Staff) filed its Recommendation that the Commission reject Spire's WNAR tariff sheets. On September 13 and September 20, Spire filed responses to Staff's recommendation stating that without agreeing with all the assertions Staff had made, Spire would file substitute revised tariff sheets and work papers that removed the billing errors associated with the October 2020 through February 2021 time period. Spire stated that rather than litigate the matter before the Commission at this time, Spire would instead pursue recovery through the mechanism established by the Commission under Chapter 13.<sup>2</sup> On September 21, Spire filed a Revised Application to Update its Weather Normalization Adjustment Rider (WNAR) and Substitute Tariffs (JG-2022-0047 and JG-

2022) (Revised Application). The September 21 substitute tariffs (“substitute tariffs”) have an effective date of October 1.

The Commission will order Staff to file a recommendation concerning the substitute tariffs and set a deadline for third-party objections or comments.

**THE COMMISSION ORDERS THAT:**

1. No later than noon on September 24, 2021, The Commission Staff shall file a recommendation concerning Spire’s Substitute WNAR Tariff Sheets JG-2022-0047 and JG-2022 filed on September 20, 2021.
2. Any party wishing to object to or comment on Spire’s substitute tariffs shall file a pleading no later than noon on September 24, 2021.
3. This order shall be effective when issued.
