ORDER SETTING DEADLINES

On September 1, 2021,¹ Spire Missouri Inc. d/b/a Spire Missouri East and Spire Missouri West (Spire) filed an Application to Update its Weather Normalization Adjustment Rider (WNAR) per sheets in Tariff Tracking Numbers JG-2022-0047 and JG-2022-0048. The tariff sheets filed under JG-2022-0047 and JG-2022-0048 bear an October 1, 2021, effective date. On September 10, the Commission's Staff (Staff) filed its Recommendation that the Commission reject Spire's WNAR tariff sheets. Staff argued that the tariff sheets improperly reflect reconciliations to recover amounts which Spire had erroneously failed to incorporate into its billing system per its tariffs effective from October 1, 2020, until February 22, 2021.² Staff contends that Spire should not be permitted to include adjustments in its new tariff sheets to reconcile billing errors resulting in prior undercharges.

On September 13, Spire filed a Response to Staff's Recommendation. Therein Spire argued that the appropriate mechanism to account for over/under charges in this instance is to follow its tariff and that pursuant to the procedure specified in its WNAR

tariffs, it had properly filed its tariffs to include the billing error amount in its semi-annual reconciliation rate.

Spire also asked for further time, until September 20, to file a more complete response to Staff's recommendation. It pointed out that the Commission's September 2 Order Directing Staff Recommendation and Setting Time for Responses had required Staff to file its recommendation no later than September 10 and required any responses thereto to be filed no later than September 13, a Monday, thereby giving Spire only one business day to respond.³ The Commission will grant the request.

THE COMMISSION ORDERS THAT:

- Spire's request for additional time to respond to Staff's recommendation is granted.
- 2. Spire shall file any further response it wishes to file to Staff's recommendation regarding Tariff Tracking Nos. JG-2022-0047 and JG-2022-0048 no later than September 20, 2021.
- 3. Staff or any other entity wishing to reply to Spire's response shall do so no later than September 21, 2021.
 - 4. This order shall be effective when issued.
