**STAFF RECOMMENDATION TO APPROVE KANSAS CITY POWER & LIGHT'S
TARIFF SHEETS FILED TO COMPLY WITH THE COMMISSION'S ORDER
APPROVING STIPULATION AND AGREEMENT AND TO GRANT MOTION FOR
EXPEDITED TREATMENT**

COMES NOW Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and submits this Staff Recommendation to the Missouri Public Service Commission ("Commission"). In support of its Recommendation, Staff respectfully states the following:

1. Kansas City Power & Light ("KCP&L") filed tariff sheets on November 8, 2013, to comply with the Commission's October 30, 2013 *Report and Order* approving a Non-Unanimous Stipulation and Agreement ("Stipulation") that addressed changes in ownership of solar renewable energy credits and changes to KCP&L's net metering interconnection tariff sheets required under House Bill 142.

2. The Commission's Energy Unit – Tariffs/Rate Design, Economic Analysis and Energy Resource Analysis Staff ("Staff") has reviewed the tariff sheets filed on November 8, 2013, and is of the opinion that these tariff sheets accord with the specimen tariff sheets contained in the Stipulation and approved by the Commission's *Report and Order* as explained in Staff's Memorandum, attached hereto as Appendix A.

3. With the November 8th filing of its compliance tariffs, KCP&L also filed a Motion For Expedited Treatment. As agreed upon under the Stipulation and approved by the Commission, the Staff does not oppose KCP&L's request for expedited approval. In addition, good cause exists under Section 393.140(11) RSMo 2000 for approval of these tariff sheets because they bring the company into compliance with the provisions of HB 142 which were effective August 28, 2013.

4. Staff has verified KCP&L has filed its calendar year 2012 Annual Report and is not delinquent on any assessment.

WHEREFORE, Staff prays the Commission accept its Recommendation and issue an order approving the following tariff sheets as filed on November 8, 2013, to become effective on November 18, 2013, the requested effective date:

Sheets Filed to Comply with the Commission's Order Approving Stipulation and
Agreement And A Motion For Expedited Treatment

DATE: November 13, 2013

On October 30, 2013, the Missouri Public Service Commission ("Commission") issued its Report and Order ("Order") in Case No. ET-2014-0027, approving Kansas City Power & Light Company's ("KCP&L") Non-Unanimous Stipulation and Agreement ("Stipulation"). KCP&L's Stipulation addressed changes in the ownership of solar renewable energy credits and changes to KCP&L's net metering interconnection tariff sheets required by the passage of House Bill 142. KCP&L also filed a Motion for Expedited Treatment ("Motion") for its tariff sheets to become effective on November 18, 2013.

KCP&L filed tariff sheets on November 8, 2013, to comply with the Order. In an accompanying motion, KCP&L requested the Commission to act on an expedited basis to approve the tariff sheets to become effective on November 18, 2013, which is less than the statutory standard 30-day period. KCP&L's Motion is based in part "... since all of the parties have already reviewed and approved the tariff sheets.", and that no harm will come to the general public if this motion is granted. In addition, the Staff and the signatories to the Stipulation agreed to not oppose KCP&L's request for expedited approval.

The Commission's Energy Unit – Tariffs/Rate Design, Economic Analysis and Energy Resource Analysis Staff ("Staff") has reviewed the tariff sheets filed on November 8, 2013, and is of the opinion that they comply with the Commission's Order. Staff is also of the opinion that good cause exists for the Commission to approve these tariff sheets on less than thirty days' notice because all signatories to the case have had the opportunity to review and approve these tariff sheets for compliance with the specimen tariff sheets contained in the Stipulation and have agreed to not oppose expedited approval. Therefore, Staff recommends the Commission issue an order approving the following tariff sheets as filed on November 8, 2013, to become effective on November 18, 2013, the requested effective date:




