STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and, pursuant to the Commission's Order Directing Filing (Order) issued July 10, 2012 in the above captioned cases, states as follows:

- 1. On March 14, 2012, the Commission issued its Order Approving Unanimous Stipulation and Agreement in which Liberty Energy (Midstates) Corp. (Liberty) agreed to maintain Atmos Energy Corporation's (Atmos) current tariffs and to formally adopt Atmos' tariffs.
- 2. On July 2, 2012, Liberty filed two tariff sheets requesting approval of its formal adoption notice and title sheet.
- 3. Staff has reviewed the tariff sheets and has determined that the sheets are in compliance with the Commission's Order Approving Unanimous Stipulation and Agreement.
- 4. On July 2, 2012, Liberty also filed its request for adoption of a fictitious name styled *In the Matter of the name Change Request of Liberty Energy (Midstates)*

Corp. to Liberty Energy (Midstates) Corp. d/b/a Liberty Utilities, docketed in GN-2013-0001.

5. Commission Rule 4 CSR 240-2.060(5) governs filing requirements when a company proposes to adopt a different or fictitious name:

A name change may be accomplished by filing the items below with a cover letter requesting a change of name. Notwithstanding any other provisions of these rules, a non-attorney may file the items required herein. Applications for approval of a change of a name shall include:

- (A) A statement, clearly setting out both the old name and the new name;
- (B) Evidence of registration of the name change with the Missouri secretary of state; and
- (C) Either an adoption notice and revised tariff title sheet with an effective date, which is not fewer than thirty (30) days after the filing date of the application, or revised tariff sheets with an effective date, which is not fewer than thirty (30) days after the filing date of the application.
- 6. Staff reviewed the request for name change and determined that Liberty has complied with the rule requirements and recommends approval of Liberty's request.

 Please see Staff's recommendation contained in its Memorandum attached as Appendix A.

WHEREFORE, for the reasons stated above and in Staff's Memorandum, Staff recommends the Commission issue an order approving Liberty's tariff sheets requesting formal adoption notice and title sheet and Liberty's requested name change.

On August 1, 2011, Atmos Energy Corporation and Liberty Energy (Midstates) Corporation (Liberty) filed a Joint Application of Atmos Energy Corporation (Atmos) and Liberty Energy (Midstates) Corp. for Authority to Sell Certain Missouri Assets to Liberty Energy (Midstates) Corporation and, in Connection Therewith, Certain Other Related Transactions (Sale) with Liberty Energy (Midstates) Corporation as the surviving entity. On February 17, 2012, a Unanimous Stipulation and Agreement (S&A) was filed in the case, and on March 14, 2012, the Missouri Public Service Commission (Commission) issued its Order Approving Unanimous Stipulation and Agreement.

In that S&A, Liberty agreed to maintain Atmos' current tariffs and to formally adopt Atmos' tariffs upon Commission approval of the sale.

On July 2, 2012, Liberty filed two tariff sheets requesting approval of its formal adoption notice and title sheet, in compliance with the Commission's Order in GM-2012-0037. Staff has reviewed the tariff sheets and determined that the tariff sheets are in compliance with the Commission's Order.

Since the Commission's approval of the S&A, Liberty has filed for a name change to Liberty Energy (Midstates) Corporation d/b/a Liberty Utilities (Liberty Utilities) on July 2, 2012. That case is docketed as GN-2013-0001.

Staff has reviewed Liberty Utilities request for name change and has determined that its request was filed in accordance with Commission Rule 4 CSR 240-2.060(5) which provides: A name change may be accomplished by filing the items below with a cover letter requesting a change of name. Notwithstanding any other provisions of these rules, a non attorney may file the items required herein. Applications for approval of a change of a name shall include:
