ORDER GRANTING MOTION FOR EXTENSION OF TIME

On September 21, 2022, The Empire District Gas Company (EDG) d/b/a Liberty filed the above-referenced application. The Commission granted the application (order) on January 25, 2023. That order bore an effective date of February 24, 2023.

On February 24, 2023, Spire Missouri, Inc., filed an application for rehearing. The Commission's Staff (Staff) filed a motion requesting additional time to respond. The Commission granted Staff's motion, and ordered Staff to respond no later than April 12, 2023.

On April 10, 2023, Staff filed a Second Motion for Extension of Time. Staff explained that the parties are working to resolve their differences. To allow time for the parties to do so, Staff asks the Commission to extend the parties' deadline to respond the application for rehearing for 30 days.

The Commission finds the request reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. The Motion for Extension of Time is granted.
2. The Staff of the Commission shall respond to the application for rehearing no later than May 10, 2023.
3. Any other party who wishes to respond shall do so no later than May 10, 2023.
4. This order shall become effective when issued.
