MOTION TO AMEND PROCEDURAL SCHEDULE

COMES NOW Petitioner, Charles A. Cooper and requests that the Commission amend the procedural schedule adopted in its Order of May 11, 2004. In support of this request Petitioner shows the Commission as follows:

1. Petitioner's direct testimony filing is due on June 8, 2004. Petitioner recently had a death in the family and due to unavoidable commitments related to this family matter Petitioner is unable to meet the June 8, 2004 filing deadline for direct testimony.

2. Petitioner has contacted the other parties in this matter and requested a 10-day extension to file direct testimony. Changing the date for direct testimony from June 8 to June 18. Petitioner also requests that the other testimony filings be moved back 10 days also, thus rebuttal testimony would be moved from July 23, 2004 to August 2, 2004 and surrebuttal testimony would be moved from August 2, 2004 to August 12, 2004.
