JOINTLY PROPOSED PROCEDURAL SCHEDULE

COME NOW Missouri Gas Energy, a division of Laclede Gas Company (“MGE”), the Staff of the Missouri Public Service Commission, the Office of the Public Counsel (“Public Counsel”), and Midwest Gas Users’ Association (“MGUA”), collectively “the Parties”, and hereby submits this *Jointly Proposed Procedural Schedule*. In support hereof, the Parties state as follows:

1. In a prehearing conference held on February 21, 2014, The Regulatory Law Judge presiding in the case directed the Parties to file a jointly proposed procedural schedule as soon as possible. This filing complies with the RLJ’s request.

2. The Parties jointly propose the following procedural schedule to be adopted by the Commission:

3. The Parties suggest that this proposed schedule will permit the Commission to issue an order to be effective April 5, 2014, the statutory 120-day deadline for the Application.
