ORDER GRANTING MOTION TO CHANGE PROCEDURAL REQUIREMENTS

On December 19, 2016, the Office of the Public Counsel filed a *Motion for Reconsideration of Procedural Requirements*. This motion requested that the Commission change the response time for data requests so that responses can be received prior to the date of the hearing. Laclede responded in opposition to Public Counsel's request citing Public Counsel's delay in making its objections to the infrastructure replacement surcharge (ISRS) and Laclede's objections to the issues raised by Public Counsel.

The Commission has considered the motion and the response. Because of the limitations of the procedural schedule due to the operation of law date and the holidays, the Commission will grant Public Counsel's motion with regard to data responses after rebuttal testimony.

THE COMMISSION ORDERS THAT:

1. The response time for data requests submitted on or after December 23, 2016, shall be three business days.

2. This order shall be effective when issued.


