**ORDER SUSPENDING TARIFF AND SETTING PROCEDURAL SCHEDULE**

On February 11, 2013, Summit Natural Gas ("Summit") of Missouri, Inc., the Staff of the Commission ("Staff") and the Office of the Public Counsel ("OPC") filed a Joint Procedural Schedule Proposal. Upon review of the proposal, the Commission finds it reasonable, and will adopt it.

**THE COMMISSION ORDERS THAT:**

1. The proposed tariff sheet submitted on December 28, 2012, by Summit Natural Gas ("Summit") of Missouri, Inc., and assigned Tariff No. JG-2013-0300, is suspended for a period of 60 days beyond March 30, 2013, to May 30, 2013, or until otherwise ordered by this Commission.

2. Data request responses are due within 10 calendar days of receipt, and data request objections are due within 5 calendar days of receipt. Any data request issued to or by the Staff shall be submitted and responded to in the Commission's Electronic Filing and Information System (EFIS).


